

## Cryptocurrency Deposit Bonus- Terms & Conditions

The “ThinkMarkets Cryptocurrency Deposit Bonus” (“Promotion”) Terms and Conditions is an integral part of the Promotion and should be considered before participation.

From 18<sup>th</sup> September until 31<sup>st</sup> December 2023 inclusive (“Promotion Period”), approved ThinkMarkets live clients registered under the Think Capital Limited (Bermuda) entity have the opportunity to earn a 2.5% deposit bonus on any direct cryptocurrency deposits received during the promotion period.

How is the deposit bonus calculated?

Any eligible deposit made via a direct cryptocurrency deposit can be eligible for a 2.5% bonus, this is calculated by adding 2.5% to the amount received by ThinkMarkets, for example if \$10,000 was received by ThinkMarkets, an additional 2.5% could be added to your trading account.

### How to participate:

- You must be a live, approved client of ThinkMarkets registered to the Think Capital Ltd entity.
- You must make a single, direct cryptocurrency deposit of at least US\$2,000.
- After making a direct cryptocurrency deposit to your ThinkMarkets trading account you must contact [support@thinkmarkets.com](mailto:support@thinkmarkets.com) requesting the deposit bonus be applied. By requesting this you agree to these Terms and Conditions. You must contact [support@thinkmarkets.com](mailto:support@thinkmarkets.com) every time during the promotion period you wish to have the deposit bonus applied should you make multiple cryptocurrency deposits.

Example:

- You have a live, approved account with ThinkMarkets and make a direct deposit to your trading account of \$10,000 via USDT (ERC20).
- After you make the transfer, you contact [support@thinkmarkets.com](mailto:support@thinkmarkets.com) requesting the deposit bonus to be applied to your trading account.
- ThinkMarkets will apply a 2.5% ( $\$10,000 \times 2.5\% = \$250$ ) bonus to your trading account within 48 hours
- Your account equity will then be \$10,250.

### Minimum trading requirement for bonus withdrawals:

The bonus applied to your trading account will only be available for withdrawal once you have met the minimum trading requirements. During the promotion period you must trade at least 5 round trip (i.e. open & closed) standard lots of FX or Gold, or a combination of the two, per \$50 bonus applied. No other instruments will be eligible. Until the minimum trading requirements are met during the promotion period, the 2.5% bonus applied is unavailable to be withdrawn.

## Terms and Conditions

Terms & Conditions are to be read in conjunction with ThinkMarkets general Terms & Conditions and relevant Disclosure Statement.

- 1.1. This promotion runs between 18<sup>th</sup> September 2023 and 31<sup>st</sup> October 2023. All requirements must be met within this period.
- 1.2. Only direct cryptocurrency deposits received and applied to your trading account will be considered for their eligibility. The list of tokens accepted can be found within ThinkPortal, but include; USDT (ERC20 & TRC20), Bitcoin, USDC (ERC20), Binance USD (ERC20) and more.
- 1.3. You must also deposit at least \$2000 in a single deposit to be eligible, transfers below \$2000 are ineligible and will not accumulate should multiple deposits be made during the promotion period.
- 1.4. Internal transfers (transfers from one of your accounts to another account, or transfers out of your account and redepositing to the same or another trading account) are not eligible for consideration for participation in this promotion.
- 1.5. You must also meet the trading requirements in order to be eligible to withdraw the bonus.
- 1.6. The maximum a client can be paid as a bonus during the promotion is \$10,000.
- 1.7. Clients who reside in Vietnam are not eligible for this promotion.
- 1.8. ThinkMarkets does not accept third-party payments.
- 1.9. The bonus will be applied to your trading account typically withing 48 hours of becoming eligible.
- 1.10. The bonus may be removed no earlier than 30 days after the end of the promotion should the minimum trading requirements not be met.
- 1.11. ThinkMarkets reserves the right to change or modify any of the terms and conditions or stop this Promotion at any time.
- 1.12. Only retail clients of ThinkMarkets are eligible.
- 1.13. Any kind of IP match between two or more clients shall be grounds for disqualification. Therefore, any trading activities from these disqualified clients will NOT be counted towards the Trade Requirement.
- 1.14. Excessive hedging or churning is prohibited, and participating clients will be disqualified.
- 1.15. ThinkMarkets reserves the right, at its reasonable discretion:
  - a) To decline any client participant in the Promotion; and
  - b) Disqualify any participant in the Promotion who tampers or attempts to tamper with the operations of the Promotion or breaches these terms and/or any of the terms and conditions set forth as per the Terms & Conditions of this Promotion; and
  - c) Disqualify any clients deemed to be employing toxic trading strategies. Therefore, any activities from these disqualified clients will not be counted towards the trading requirements.

- a. Failure to send the correct token will result in loss of funds which ThinkMarkets is not liable for. The tokens we accept are mentioned inside ThinkPortal, see the brackets beside the coins. Please contact ThinkMarkets if you require any assistance with making a deposit.

ThinkMarkets will not be held liable or responsible in any manner whatsoever for any problems or any losses incurred by participating traders, or any combination thereof, including any injury or damage resulting from participation in the promotion, or the use of cryptocurrency to fund a trading account.

- d. It is at our sole discretion to determine if a clients activity will qualify to participate in this Promotion.

- f. We reserve the right to withhold the deposit bonus, when in our reasonable belief, there has been co-operation, collusion or organization for the purpose mis-using the Promotion.
